

# Achieving One World Christianity



It is hardly a secret that pope Francis and his recent predecessors have made unification with all other mainstream "Christian" denominations a top priority. He recently concluded a visit to Turkey, and met with President Erdogan as well as the head prelate of the Eastern Orthodox church, Patriarch Bartholomew, Archbishop of Constantinople. The pope shared a podium with Erdogan to condemn the murderous exploits of ISIS. Erdogan, for his part, said the biggest problem in the region is Western "Islamophobia."

But the pope and Eastern Orthodox Bartholomew reaffirmed their commitment to cooperation saying that they're willing to operate in unity. Despite 900 some years of divorcement, the two organizations have in recent years referred to one another as "two lungs in the same body."

While condemning the brutality of ISIS and terrorism in Turkey, Francis called on Europe to welcome rising numbers of refugees and immigrants from the Middle East, most of whom are Muslims.

In addition to overtures extended to Archbishop Bartholomew, Pope Francis has also headed a campaign reaching out to the "schismatic Old Catholic Church." These include break-away protestant churches all over Europe that are allied with the Anglican Church.

Pope Francis reached out to Pentecostals through an intermediary sent to Dallas, Texas. He sent a "heartwarming" video encouraging "Christian unity" to a "gathering of Pentecostals" including Kenneth Copeland and Bishop Anthony Palmer, described as a "leading member" of the Euro-Church, a "confederation of Protestant Evangelical leaders working in Europe." The message from the meeting seems to have been that "doctrinal differences" don't matter and they can all be "sorted out in heaven." (Palmer, recently deceased, reportedly died in a motorbike accident.)

Under the headline Francis, Ecumenism, and the Common Witness to Christ, The Catholic World Report published the following paragraph. "The Catholic Church being the mammoth institution that it is—with an estimated 1.2 billion out of the approximately two billion Christians in the world, under one highly visible leader in Rome—ecumenism comes more naturally to it than to smaller groups, which can be understandably afraid of being swallowed whole in the process of reconciliation. But today we see a growing cooperation

among the recognized leaders from Christian communities of both the East and the West. The most active among these is Bartholomew I, Ecumenical Patriarch of Constantinople, who began tearing down the walls of separation with John Paul II, worked closely with Benedict XVI, and has been present for Francis from the very outset of his papacy. Also conspicuous are the actions of Justin Welby, the archbishop of Canterbury, who recently surprised everybody by inviting a Catholic ecumenical community.

Chemin Neuf ("A New Walk"), to live in his historic residence, Lambeth Palace, in order to "pray and work for unity."

The article goes on to detail how Francis went on a "private visit" to a Pentecostal church in Caserta, Italy to promote unity, and concluded his

remarks by apologizing for whatever role the Catholic church may have played in the persecution of protestants during the 1930s. According to the report, that is when the world media woke up to what was going on. But it was just the start of what became a parade by invitation to the Vatican for lengthy consultations with the pope, as the article goes on to reveal.

"But Caserta was only the latest of many events coming within the compass of the Holy Father's efforts to reach out to evangelicals and Pentecostals." Then we're told that the Green family, owners of Hobby Lobby, a delegation including Joel Olsteen, Senator Mike Lee (Mormon), Gayle D.

Beebe (president of interdenominational Westmont College in Santa Barbara) and Pastor Tim Timmons (founder of California based South Coast Community Church) have all been to the Vatican to consult with the pope.

"Then, on June 24th, there was an unprecedentedly long, informal meeting and lunch at *Domus Sanctae Martae* with famed televangelist James Robison and his wife; the two top officers of the World Evangelical Alliance, Global Ambassador Brian Stiller and Secretary General Geoff

Tunnicliffe; Kenneth Copeland, whose ministry belongs to the Word of Faith Movement; John and Carol Arnott, co-presidents of Catch the Fire Ministries in Toronto; and Evangelical Episcopalian Bishop Anthony Palmer."

The Pope appeals to all the disparate "leaders of Christianity" with "a yearning for a return to lost unity, a desire to achieve a missing fullness, a disarming invitation to simply come together to witness to the beauty of the love of Christ." Believe it or not, this kind of fluff is working!

"In introducing the Pope's message, Palmer provided scriptural context ("a spirit of reconciliation") as well as up-to-date information on the Lutheran

of the Lutheran Church believe and confess that by grace alone, in faith in Christ's saving works and not because of any merit on our part, we are accepted by God and receive the Holy Spirit, who renews our hearts while equipping and calling us to good works.

"This brought an end to the protest of Luther," Palmer told his audience. "We preach the same gospel now!" Looking around, after a pause, he added: "Luther's protest is over. Is *yours?*"



A cross the world, month after month, year after year, within country after country, hundreds of varied and differing religious holidays and holy days are observed by the adherents of many and varied religions; each worships their particular god, distinct to each particular religion.

One holiday, recognized across the globe, but particular to some 2.18 billion Christians around the world, is Christmas.

The history of Christmas reveals many an irony and much duplicity. To learn the truth about Christmas, one simply needs to read any of the many Christmas related history books or Google search "the history of Christmas" or simply watch programs like the History Channel's "Christmas Unwrapped."

The intermingling of the nativity of Jesus Christ with many pagan religious traditions and folk tales is obvious. Most rituals and customs common to Christmas are clearly connected to early pagan traditions from Rome and countries across northern Europe and the British Isles. Considered a religious holiday, Christmas these days is loaded with commercialism, consumerism and pageantry. It is a time that makes merry the heart, for after all, 'tis the season to be jolly, for it's the most wonderful time of the year. Less noticeable, year after year is Jesus Christ.

In the United States, considered a Christian country, Christmas is more than a religious holiday; it is a national observance, much like a national institution. Christmas is a day on which federal, state and local governments shut down and practically all business, as well as private and public institutions close for the day. In the United States of America, Christmas is such a well established holiday that even non-Christians join in the celebration, taking advantage of the time off work.

Between 1609 and 1775, nearly one-half million Europeans from Northern Europe, mainly from England, with some from Scotland, Scandinavia,

and Germany, made their way to what would become the United States of America. Many of these immigrants had hopes of securing a brighter economic future. Many made their way to the new British colony to flee religious persecution, to flee the hypocrisy and persecution of the Church of

1681, and the Plymouth colony made celebrating Christmas a criminal offense.

As history reveals, many Christians who were not as strict as the Puritans or careful about their religion, "took underground" their Christmas revelry and debauchery, the likes of



They came from England to seek a new life and a place to practice their religion. They arrived in Plymouth, Mass in 1620.

England.

Among the many, mostly Christian peoples to come to the new world, were the Puritans. The Puritans were Protestant Christians who made significant contributions to colonial ways of life and the governmental structure of the colonies. In the mid-seventeenth century, Puritan Christians, both in America and England, were instrumental in the passing of laws, which made it illegal to observe Christmas. Their reasoning was simple: it was an insult to God to honor a day associated with ancient paganism. With Puritan dogma and religious doctrine in force, Christmas was outlawed in Boston from 1659 to

dancing, singing, merry-making, yule fires, mistletoe, drinking and saturnalia exploits, during that time. As time progressed into the 19th century, with the assistance of Christian Sunday schools along with the likes of Charles Dickens and Clement Clarke Moore, Christmas once again became an integral part of Christian worship in America. Catholic and Protestant Christians alike, embraced Christmas, with all its traditions.

As faithful to the Bible as the Puritans seemed to be, they never saw the deception foisted upon the world by the Catholic Church when it came to the Lord's Day or Easter. The Puritans could see the paganism associated with Christ-

mas. Why could they not see the paganism of Sunday worship? Why did the Puritans reject the seventh day (Saturday) Sabbath, when Jesus Christ clearly said he is the Lord of the Sabbath and He did not come to do away with the Laws of God? Why did the Puritans reject God's teachings about the Sabbath and continue the Catholic and Anglican tradition of pagan (Sun) day worship?

These questions aside, the Puritans and other Protestant Christians had a substantial and imposing influence on this nascent British American Colony in the 17th and 18th centuries. What was initially religious freedom for most became religious tyranny for others.

In 1639, New England Puritans drafted a constitution affirming their faith in God and their intentions to organize a Christian nation as "a shining city upon a hill."

In 1775, nine of the 13 colonies had state established Christian churches. Although a variety of Christian denominations were tolerated, each colony had one dominant or favored denomination, which was treated with financial favor. All 13 colonies required office-holders to be Christian; those who professed faith in Jesus Christ. That requirement of course changed with Article VI of the United States Constitution, which ensures that no religious test shall ever be required as a qualification for an individual to hold office or public trust under the United States.

By 1776, with the exception of some 2,500 Jews, 98% of the European Americans who came

to the colonies identified themselves as Protestant Christian and some 1.9% identified themselves as Catholic. Protestant Christian principles and values were clearly prevalent in these British American colonies.

Not only the strident and moral absolutism required of the Puritans but also Quaker Christians from Pennsylvania made it clear what behaviors would not be allowed in their territory. Article 38 of the "Character of Liberties and Frame of Government of the Province of Pennsylvania" listed offenses to God, some of which were swearing, cursing, lying, profane talking, drunkenness, obscene words, incest, sodomy, stage-plays, dice, masques, bull-baiting, cock-fighting and behaviors that excite the people to rudeness, cruelty, looseness and irreligion.

Early colonial laws, charters and constitutions such as the Mavflower Compact, the Fundamental Orders of Connecticut or the Massachusetts Body of Liberties were principled with Christian ideology and naturally so, as the authors of these rules and documents were Christian. In the early years of the British colonies, Christian religious groups were influential and most attempted to enforce strict religious observance in both colonial territorial governments and local town rules. Laws mandated that everyone attend a house of worship and pay taxes, which funded the salaries of ministers Dissenters who sought to practice or proselytize a different version of Christianity or a non-Christian faith were oftentimes persecuted.

Although most colonists considered themselves Christians, this did not mean that all lived in a culture of religious unity. Instead, differing Christian groups often believed that their own practices and faiths provided unique values that needed protection against those who disagreed, driving a need for additional rules and regulations.



Virginia's 1610 legal code included that the colonists embark on a "sacred cause" which required church attendance twice every Sunday; in addition it proclaimed that anyone who spoke impiously against the Trinity or who blasphemed God's name be put to death. Consider if these regulations were the law of the land today?

Thorough reading of the lives of the Founding Fathers provides consistent evidence that these men respected and acknowledged the universal teachings of Jesus Christ. With regard to organized religion, several rejected Roman and Anglican dogma and the Pauline version of Christianity. Others had varying degrees of association with Christian congregations.

Among the Founding Fathers were Deists, admiring the teachings of Christ in addition to other great philosophers and orators of Roman & Western philosophy. Several of the Founding Fathers were Freemasons. All the Founding Fathers were educated under the ideology and philosophy of the Enlightenment. As such, these men were inspired by and promoted reason, individualism, empiricism, science, rationalism, & natural liberties while rejecting authoritarianism, tradition, religious revelations, absolutism, autocracy and religious intolerance.

Not that these men were irreligious or detractors of Christianity; their principle concern was that no one religion or religious dogma or doctrine took precedence over another. These men were witness to not only the abuses of the British monarchy, but also the theocratic dogmatism of the Protestant Church of England. The Founding Fathers were very much aware how Christian dogma was influencing governmental structure and behavior within the colonies.

They felt strongly that the liberty of personal choice of worship had to be upheld and not dominated by any one particular Christian denomination. Belief in the teachings of Jesus was one thing, but to promote one particular religion or Christian denomination over another or to

# GERMANS RISE UP AGAINST ISLAMIZATION

There is a mounting public backlash over what many perceive as the government's indifference to the growing influence of Islam in German society. This backlash represents a potentially significant turning point.

Despite efforts by German politicians and the media to portray PEGIDA as neo-Nazi, the group has taken great pains to distance itself from Germany's extreme right. The group says that it is "apolitical" and that its main objective is to preserve what is left of Germany's Judeo-Christian culture and values.

"Many people in Germany have legitimate concerns about the spread of radical Islamic ideology, which promotes violence against non-Muslims, robs women and girls of their natural rights, and seeks to require the application of Sharia law.... Because the rule of law, tolerance and freedom of religion are fundamental Western values, the PEGIDA movement must leave no doubt that it

is precisely these values that it seeks to defend."

Thousands of German citizens have been taking to the streets to protest the growing "Islamization" of their country.

The protests are part of a burgeoning grassroots movement made up of ordinary citizens who are calling for an end to runaway immigration and the spread of Islamic Sharia law in Germany.

The guardians of German multiculturalism are fighting back: they are seeking to delegitimize the protesters by branding them as "neo-Nazis" and by claiming that the Islamization of Germany is a myth contrived by misinformed citizens.

But there is a mounting public backlash over what many perceive as the government's indifference to the growing influence of Islam in German society. This backlash represents a potentially significant turning point—one that implies that the days of unrestrained German multiculturalism may



be coming to an end.

The latest protest took place in the eastern German city of Dresden on December 8, when more than 10,000 people defied freezing temperatures to express their displeasure with Germany's lenient asylum policies.

Germany—which is facing an unprecedented influx of asylum seekers, including many from Muslim countries—is now the second most popular destination in the world for migrants, after the United States.

The Dresden protest was organized by a new citizens initiative, "Patriotic Europeans Against the Islamization of the West," better known by its German abbreviation, PEGIDA, short for "Patriotische Europäer gegen die Islamisierung des Abendlandes."

PEGIDA, which has been organizing so-called "evening walks" (Abendspaziergang) through downtown Dresden every Monday evening since October, has seen the number of protesters increase exponentially from week to week.

Similar anti-Islamization protests have been held in the western German cities of Hannover, Kassel and Düsseldorf, where 400 people showed up on December 8 for demonstration organized by a PEGIDA offshoot, named DÜGIDA.

These protests are similar to, but separate from, other mass demonstrations organized in Cologne and other German cities by a group called Hooligans against Salafists, or HoGeSa.

PEGIDA was launched by Lutz Bachmann, a 41-year-old Dresden native with no background in politics, after government officials in the eastern German state of Saxony announced that they would be opening more than a dozen new shelters to house some 2,000 refugees.

Bachmann says that he is not opposed to legitimate asylum seekers, but that he is against so-called economic refugees who are taking advantage of Germany's generous asylum laws in order to benefit from the country's cradle-to-grave social welfare system. According to Bachmann, most of the asylum seekers in Saxony are males who have left their families behind in war-torn Muslim coun-

bors and let us show the counter-demonstrators that we are not xenophobic."

Placards displayed by protesters in Dresden included slogans such as "Against Religious Fanaticism," "United against a Holy War on German Soil," "Homeland Security Rather than Islamization," and "For the Future of our Children." There was no visible sign of neo-Nazi propaganda at the event.

On December 10, PEGIDA published a "Position Paper" outlining what the group is "for" and "against" in 19 bullet points. These include:

# "Patriotic Europeans Against the Islamization of the West," better known by its German abbreviation, PEGIDA

tries.

Ahead of the march on December 8, PEGIDA posted the following call to action:

"Dear friends, dear fellow citizens, dear patriots! Monday is PEGIDA Day and today too we want to show that we are peaceful. Bring your friends and neigh-

- "1. PEGIDA is FOR the acceptance of asylum seekers from war zones, or those who are subject to political and religious persecution. This is a human duty!"
- "2. PEGIDA is FOR amending the Basic Law of the Federal Republic of Germany to include a list of the right and the responsibility for immigrants to integrate."
- "9. PEGIDA is FOR a zero-tolerance policy vis-à-vis asylum seekers and migrants who commit crimes in Germany."
- "13. PEGIDA is FOR maintaining and protecting our Judeo-Christian Western culture."
- "16. PEGIDA is AGAINST the establishment of parallel societies/parallel legal systems in our midst, such as Sharia Law, Sharia Police, and Sharia Courts, etc."

"18. PEGIDA is AGAINST religious radicalism, regardless of whether it is religiously or politically motivated."

"19. PEGIDA is AGAINST hate preachers, regardless of religious affiliation."

In a classic case of shooting the messenger rather than heeding the message, German politicians have dismissed PEGIDA protesters as ignorant and racist.

German Interior Minister Thomas de Maizière characterviews in the heart of society."

But Bachmann says the protests will continue until there are changes to Germany's asylum policies. "We do not want to launch a political party or start a revolution," he said. "But we need to talk openly about the asylum issue."

Meanwhile, the Christian Social Union [CSU], the Bavarian partner of Chancellor Angela Merkel's CDU, has watered down a demand that migrants settling

ized PEGIDA as "shameless," adding: "We have no danger of Islamization, certainly not in Saxony or Dresden with 2.2% immigrant population."

In an interview with the German newsmagazine *Der Spiegel*, Justice Minister Heiko Maas said:

"There are limits to the political battle of ideas. All political parties should clearly distance themselves from these protests. We cannot be silent if a xenophobic atmosphere is being built on the backs of people who have lost everything and come to us for help: We have to be clear that the demonstrators are not the majority."

A politician with the ruling Christian Democratic Union [CDU], Wolfgang Bosbach, warned that the protests represented the "anchoring of radical in Germany on a permanent basis should speak German at home.

The "politically incorrect" proposal appeared in a draft policy paper on December 7. Following an outcry, the proposal was quickly amended to read that migrants who want to live in Germany permanently should be "motivated," rather than "obliged," to speak German "in daily life," rather than "in public and within the family."

In October, it emerged that so many asylum seekers were converging on Bavaria that they needed to be housed in tents normally used for the annual Oktoberfest.

In September, the governor of Bavaria and leader of the CSU party, Horst Seehofer, called for the return of border controls with Austria to stem the tide of refugees seeking asylum in Germany.

The Schengen Agreement, which entered into effect in 1995, abolished internal borders within the European Union, enabling passport-free movement between most countries within the bloc.

Although international law holds that migrants are supposed to claim asylum in the first country they reach, many are taking advantage of Europe's open borders to claim asylum in Germany after first passing through Italy and Austria.

Seehofer also lashed out at Italian authorities, who he said are not doing enough to stop the flow of migrants entering the EU through Italy, after crossing the Mediterranean Sea from Africa. In an interview, he said:

"Italy is in clear violation of the Schengen accords. If this does not stop, Germany has seriously to consider stopping this violation via border controls. We must set quotas for refugees in Europe. And we have to deal with the fact that refugees need to be shared out among EU members fairly."

Bavarian officials estimate that at least 33,000 asylum seekers have arrived in the state during 2014, twice the number of arrivals registered in 2013.

In an effort to stem the flow of asylum seekers, the CSU has demanded that the central government begin cracking down on so-called welfare tourism. The CSU is concerned that the problem of runaway immigration is prompting traditional supporters of the party to defect to the Alternative for Germany (AfD), an upstart political party formed in 2013.

They suppose they are doing this in honor of Christ's birthday, which they erroneously believe was on December 25. History proves Christ was born in the *autumn*, very likely on the First Day of the Feast of Tabernacles, not in the middle of winter.

God's Word shows Christ was "tabernacling" (dwelling only temporarily) in human flesh (John 1:14); that He came to this earth for many important purposes.

What were the real reasons for the very Person of the Godhead Who said, "Let there be light," and "Let Us make man in Our image," to *become human flesh?* Study carefully the entire first chapter of the Gospel according to John for *proof* of Christ's pre-human state.

Did Jesus Christ come to give us a new and different religion? Did He come to bring peace? Did He come to save the world? Did He come to revive the synagogue? Did He come to heal everyone He could, cast out every demon He encountered, teach every person He met, and convert as many as possible?

No, believe it or not, Jesus Christ did not come to save the world—then! Had Jesus Christ decided to "save" the world, He would have done it. Instead, He told His disciples: "Think NOT that I am come to send peace on earth; I came NOT to send peace, but a sword (a symbol of violent death; symbol of war!)

"And a man's foes shall be those of his own household" (Matthew 10:34-36).

Are you mature enough; is your mind open and inquiring enough to really think about that scriptural passage? Do you *believe it*? Christ said it. He meant it. He did not come to bring peace during His physical lifetime of "tabernacling" in human flesh.

But what of the oft-repeated phrase, "peace on earth?" It is a blatant *mistranslation* in the King James Bible of 1611. Most marginal references clear it up: the Oxford KJV margin says, "Or, on earth peace among men of good will, or, on earth peace among men in whom He is well pleased" (Luke 2:14).

Christ Himself tells you He did not come to bring peace on this earth. Eventually He will, but that time is in the future.


"And in them is fulfilled the

# na: Turning Away from The Dollar

Questions remain over the global economic impact of Beijing's efforts to reduce its financial reliance on the U.S.

Then an economic theme goes global, Hollywood is never far behind. In the futuristic thriller Looper, retired hit man Bruce Willis travels back in time from the year 2074. Upon meeting his younger self, he advises him to stop learning French and instead head to China. In the future, Shanghai is the centre of the world and the *renmin*bi the currency of choice.

While time travel and flying cars may not be on the horizon, at least one aspect appears closer to reality and movie bad guys are not the only ones eager to get their hands on a few "redbacks". An "age of Chinese capital", as Deutsche Bank calls it, is dawning, raising the prospect of fundamental changes in the way the world of finance is wired. Not only is capital flowing more freely out of China, the channels and the destinations of that flow are shifting significantly in response to market forces and a master plan in Beijing, several analysts and a senior Chinese official say.

In a nutshell, three big and inter-related changes are under way. China's appetite for US Treasury bonds, a cornerstone of the global economy for more than a decade, is waning. Beijing is ramping up its overseas development agenda to boost financial returns and serve key geopolitical interests. The promotion of the renminbi as an international currency is gradually liberating Beijing from the dollar zone, providing it with more latitude to open up to foreign portfolio investment flows.

The reorientation of China's strategy away from Treasuries is a slow-running trend but one which intensified last month after Li Keqiang, the premier, announced a 10-point plan for financial reform. One of the points dealt with the deployment of China's \$3.9tn in foreign currency reserves, chunks of which have been recycled into Treasuries for more than a decade, helping to keep US interest rates low and underpin economic growth in the west. However, the new plan says: "Better use should be made of China's foreign exchange reserves to support the domestic economy and the development of an overseas market for Chinese high-end equipment and goods."

A senior Chinese official, who declined to be identified, elaborated on what the plan is likely to mean in practice. "This is a big change and it cannot happen too quickly, but we want to use our reserves more constructively by investing in development projects around the world rather than just reflexively buying US Treasuries," the official says. "In any case, we usually lose money on Treasuries, so we need to find ways to improve our return on investment," he says.

#### **Rewiring global finance**


Not only is China's desire to buy US debt diminishing, so is its ability to do so. The banner years of Treasury bond purchases, during which holdings rose 21-fold over a 13-year period to hit \$1.27tn by the end of 2013, were driven by an imperative to recycle China's soaring US dollar current account surpluses.

But these surpluses are narrowing sharply from the equivalent of 10.3 per cent of gross domestic product at the peak in 2007 to 2.0 per cent in 2013. In fact, if financial flows are taken into account, China ceased over the most recent four quarters to be a net exporter of capital at all.

The impact on Treasury purchases is evident in the tapering of Chinese buying over the past three years. But analysts see structural forces driving a steeper downturn in the future.

"I absolutely think we are going to see smaller Chinese current account surpluses in the future because of greater Chinese spending overseas on tourism and services and greater spending power at home may lead to more imports," says Jan Dehn, head of emerging market research at the Ashmore fund.


All of this leads to a burning question: how convulsive an impact on US debt financing — and therefore on global interest rates — will the changes under way in China have? Analysts hold views across a spectrum that ranges from those who see an imminent bonfire of US financial complacency to those who see little change and no cause for concern. Occupying a space between these extremes are those, such as Michael Power of Investec, who see potential for a disruptive rewiring



of international capital flows, but no certainty that such an outcome will transpire.

"If China starts to pursue investment programmes like developing infrastructure to regenerate the trans-Asian Silk Road, it will no longer be banking most of its surplus savings in US Treasuries," says Mr Power.


A decade ago Alan Greenspan, the then chairman of the US Federal Reserve, found his attempts to coax US interest rates upwards negated by Beijing parking its



surplus savings into Treasuries. Arguably, says Mr Power, a bond bubble has existed ever since.

"If China is now set to redeploy those deposits into capital investment the world over, does this mean the [Greenspan] conundrum will be at last 'solved' but at the cost of an imploding Treasury market?" Mr Power asks. "If so, this will raise the corporate cost of capital in the west and put yet another brake on already tepid western GDP growth."

Stephanie Pomboy, president at Macro Mavens, a US-based economics research consultan-



cy, sees a more present peril. "The conviction that the rest of the world [China and Japan in particular] have no choice but to maintain their attachment to the US dollar is as strong as ever," she says. "Wallowing in this illusion, investors see no long-term threat to the dollar's status, even as each day it diminishes in use."

#### Locked in

Others, however, say that China is effectively locked into a steady continuation of US Treasury investment because any sudden selldown of its huge holdings could send Treasury prices into a tailspin, thereby slashing the value of Beijing's position. In addition, says Jonathan Anderson of Emerging Advisors Group, China's Treasury investments are a byproduct of Beijing's intervention in currency markets to prevent the type of surge in the renminbi's value that would have eroded the competitiveness of its exports.

What is clear is that Beijing's intention to diversify the deployment of its foreign exchange reserves is strengthening. Over the Continued next page

past six months, it has driven the creation of three international institutions dedicated to development finance: the Shanghai-based New Development Bank along with Brazil, Russia, India and South Africa; the Asian Infrastructure Investment Bank and the Silk Road Fund.

Each is likely, or explicitly designated, to receive funding from the foreign currency reserves. Their importance can be judged from their centrality to President Xi Jinping's aim to realise the "Chinese dream" of recapturing the status the country enjoyed during the most powerful passages in its history, say Chinese officials. The \$40bn Silk Road Fund, announced last month, demonstrates Beijing's ambitions clearly. Set to be funded to the tune of some 65 per cent from the foreign reserves, the fund is charged with achieving Mr Xi's vision of building a "Silk Road economic belt" across central Asia to Europe and weaving a "21st century maritime Silk Road" through the sea lanes of the South China Sea and the Indian Ocean.

"By building roads and railways over its borders and upgrading ports in Asia, Beijing is tying its neighbours' prosperity to their relationship with China," says Tom Miller, senior Asia analyst at Gavekal Dragonomics, a research consultancy. "It is an attempt to restore China's position at the heart of Asia."

The infrastructure work will directly benefit the big Chinese


construction and equipment companies that are awarded contracts financed by China-backed institutions. This, in turn, should boost the country's chances of realising Mr Xi's prediction that Chinese companies will invest some \$1.25tn overseas during the next decade.

#### Renminbi

The launch of these development institutions is only one strand in China's aim to make finance serve geostrategic goals. An older, but perhaps more important element, is the promotion of the *renminbi* as an international currency. The drive to internationalise it is derived from a desire to carve out China's own space within a US-dominated global financial system.

The process accelerated with the outbreak of the global financial crisis in 2008 as policy makers in Beijing realised their economy's fate was umbilically linked to that of the US.

"We hate you guys", was how Luo Ping, an official at the China



Banking Regulatory Commission vented his frustration in 2009. He and others in China believed that, as the US Federal Reserve printed more money to resuscitate American demand, the value of China's foreign reserves would plunge.

"Once you start issuing \$1tn-\$2tn...we know the dollar is going to depreciate so we hate you guys — but there is nothing much we can do," Mr Luo told a New York audience.

In an indication of intent, Wang Qishan, then a vice-premier and now one of Mr Xi's closest allies in the Politburo Standing Committee, was appointed in 2009 to promote the use of the renminbi in trade settlement and investment around the world. The process is driven mainly by an imperative to decouple China by degrees from its financial reliance on the US and from Washington's influence over its domestic monetary policy, officials say. As a mechanism towards this end, China is earning a greater proportion of its trade and financial receipts in renminbi. Because these earnings do not have to be recycled into dollar-denominated assets, they can be ploughed back into the domestic economy, thus benefiting Chinese rather than US capital markets.

The *renminbi's* progress has been more rapid than many expected. In October, more than 22 per cent of China's trade was settled in its own currency, according to Standard Chartered, up from almost nothing five years ago. Data from Swift, the international currency clearing sys-

## Collapse of Russia's Ruble



It looks like vindication for the ancient Proverb that tells us pride comes before a fall. Russia's President Putin has flaunted an arrogance of national power and personal vanity that captured the imagination of his subjects. Russians wildly supported Putin's invasion and annexation of the Crimean peninsula. While Ukraine battled Russia's military conquest to carve out another major

swath of its sovereign territory, the rest of eastern Europe worried and wondered whether Putin's ambitions would bring another war with the potential to put them back under the Russian domination that ended in 1989. All the while Putin's stock soared with sky high popularity ratings at home.

The intervening months have seen dozens of reports of provocative Russian military actions, with fighter jets intruding into NATO airspace, menacing Japan, and Russian bombers testing the limits of air defense zones around the United States. All the while Putin swaggered on the world stage at every opportunity, and the Russian population loved it.

International economic sanctions were brought


to bear by the West to ensure that Putin recognized that his adventures in eastern Europe wouldn't go completely unchallenged. He scoffed and continued to flaunt his "devil may care" attitude. It is difficult to gauge the impact of those sanctions, but the recent and sudden 50% decline in the world's oil price is taking a major toll on the Russian economy which is largely dependent upon oil exports.

When the *ruble* recently experienced an eleven percent plunge in a single day, Russian banks responded by raising interest rates to 17%. Surely that would be enough incentive for Russians to leave their money in the bank and let it grow. But in the case of the *ruble*, even the hike to 17% interest rates

has been inadequate. News reports have Russian shoppers in a mad dash to use their *rubles* to acquire goods that have some intrinsic value, along with news of people forming long lines to get their money out of Russian banks. At the same time, every internet vendor has ceased taking orders from buyers with *rubles*.

Russian debt is currently rated "one notch above Continued on page 33

## When Comes Fifty in **Defiance of God**



s of November 2014, same-sex marriage is legal in 32 of the 50 states that are the United States of America. Adding to that total, same-sex marriage is legal within the District of Columbia and ten Native American tribal jurisdictions. judgmental on gay and lesbian issues." A full 70% of young people said the same. Additionally, a recent Pew Research Center poll found that 70% of Millennials (those born from 1981 or later) support same-sex marriage.

> Church of Christ, and Lutheran are some of those now allowing pastors to marry gay and lesbian couples.



How?



Consider what Thomas Jefferson wrote in his autobiography, discussing the Virginia Constitution (enacted in 1776). "Whereas the preamble declares that coercion is a departure from the plan of the holy author of our religion, an amendment was proposed by inserting 'Jesus Christ' so that it would read 'A departure from the plan of Jesus Christ, the holy author of our religion,'

James Madison commented, "Strongly guarded as is the separation between Religion and Government in the Constitution of the United States, the danger of encroachment by [Religious] Bodies may be illustrated by precedents already furnished in history." The Founding Fathers were witness to the exploits of the Catholic Church in Europe, the (Anglican) Church of England and the influence of Christian churches in the colonies.

Further, Thomas Jefferson, shortly after his election as America's third president, wrote to a

exercise thereof,' thus building a wall of separation between church and state."

The Declaration of Independence makes mention of religious neutral terms - "Nature's God," "Creator," "Supreme Judge of the World" and "Divine Providence," and the Constitution does not refer to a divine being, Christian or otherwise. The Founding Fathers had no intention to promote religion, Christian or otherwise, as they formulated a new government for their new country.

One principal concern among the Founding Fathers was to uphold the freedom for one to worship the God of his faith without interference or encumbrance of government. This principle comes directly from the strength of these following words: 'we hold these truths to be self-evident, that all men are created equal ... endowed by their Creator with certain unalienable rights, that among these are life, liberty and the pursuit of happiness.' Liberty, freedom of worship, was only logical and protection of the freedom of worship was imperative.

After establishing a new form of government, unique to that time, which would provide for basic civil liberties for its citizens (but we cannot say all, for slaves were considered only 3/5 of a person), Jefferson and other of the Founding Fathers still felt the Constitution was incomplete. They realized the Constitution still left out the guarantee of individual rights, including what was considered a prime guarantee: freedom from and of religion.

After much contemplation and the consideration of several drafts, the following became the legal text of the First Amendment: Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

In the United States of America today, one should give thanks for the crafting of such words, which are now law within the land. For with these words came the guarantee and full assurance of religious freedom. With these words an individual, individuals or an organization may freely worship, may freely assemble in worship of the God of one's free choice. Further, a church organization or an individual may freely

preach and freely promote their religious beliefs and may freely do the work of God.


The same law which allows Christians, Catholics and Protestants alike, to worship their God on Sunday in churches across the land, equally allows Jews to worship as they please on Saturday in their synagogues. Just as equally, those individuals and organizations whose beliefs and doctrines do not quite square with mainstream, traditional Christianity are free and able to worship as they choose, doing so in peace and protection of the First Amendment.

Not just for Christians and Jews, the benefits afforded by the First Amendment extend to Buddhists, who are free to worship and proselytize in the United States. Likewise, Hindus are free to worship in their temples and proselytize. The list continues: Jainism, Sikhism, Taoism, the Baha'i faith, Zoroastrianism. Vodou. Shintoism. Caodaism. Wicca, Druidry, Native American religions, Neo-paganism, Christian Science and Muslims. These and many more are all free within the United States of America to exercise their religious expression and to worship unabated their gods in their temples, mosques and various houses of worship.

As Thomas Jefferson remarked when referring to the Virginia Constitution, "in proof that they meant to comprehend, within the mantle of its protection, the Jew, the Gentile, the Christian and Muslim, the Hindu and Infidel of every denomination." This sentiment prevailed among the archi-

tects of the U.S. Constitution.

There are hundreds of varied and differing religions across the world and practically all have made their way to the United States of America, allowing all who desire to worship in freedom with impunity. America is a pluralistic nation and regarding religion, America is a religiously pluralistic nation. As such, all religions are acceptable and none can be discriminated against. One

is just as good as the other. It has to be that way, for from its establishment, the principles of liberty and equality have been maintained. The freedom to worship is undeniable and absolute in the United States.

In retrospect, the decision of the Founding Fathers to remain religion-neutral, rather than promote any one particular religion or any one particular Christian denomination over any other, was epic. The Founding Fathers did not capitulate to the desires of Christian peoples and Christian denominations of the 17<sup>th</sup> and 18<sup>th</sup> centuries when writing the

Constitution. Had they done so, religious freedom and freedom to worship today would look nothing like it now does.

Although fewer in number and scarcely recognized in the milieu of the American religious experience, there are those who are called Sabbatarians. These religious people believe in Jesus Christ as the only Savior of mankind and read from the same Bible as does the general Christian community. The glaring difference between Sabbatarians and Christians is the day on which they worship. Sabbatarians worship on and keep holy the seventh day of the week, Saturday, Sabbath. In addition to worshiping on the day God made holy, many Sabbatarians also worship on and observe God's seven annual Holy Days (as enumerated in Leviticus 23). Sabbatarians are certainly in the minority in this Christian nation. Yet, they are able to exercise their religious convictions under the protection of the First Amendment.

For the Sabbatarian, the Jew, the Gentile, the Christian and Muslim, the Hindu and Infidel of every denomination, freedom to worship is a liberty provided within the United States of America. This freedom, ensured by our Founding Fathers, allows all to exercise their religious convictions as they choose, to worship the god they choose, to practice the religion they know.

Freedom to worship unconstrained begs the question. You are guaranteed freedom to worship. You have been given the liberty of choice. Which God then will you worship?

The AfD—which wants Germany to leave the euro single currency and promotes a tough line on immigration—received 4.7% of the vote in the September 2013 federal election, narrowly failing to reach the 5% threshold needed for representation in Germany's national parliament.

Since then, support for the AfD has surged. The party has extended its gains in regional

elections, and also won nine seats in European Parliament elections in May 2014. A poll published in September 2014 found that one in ten German voters now support the AfD.

Germany's political establishment has worked hard to discredit the AfD. But if the party continues to siphon voters away from the mainstream parties, the AfD will be in a position to influence the debate over the future of German multiculturalism.

The AfD has already come out in support of the PEGIDA protests in Dresden. AfD spokesman Konrad Adam said the party has a "fundamental sympathy for the PEGIDA movement."

AfD leader Bernd Lucke, a professor of macroeconomics at Hamburg University, summed it up this way:

"Many people in Germany have legitimate concerns about Continued next page

the spread of radical Islamic ideology, which promotes violence against non-Muslims, robs women and girls of their natural rights, and seeks to require the application of Sharia law. That citizens are expressing these concerns in nonviolent demonstrations is good and right. It is a sign that these people do not feel that their concerns are being taken seriously by politicians. It is an incentive for all politicians to act more decisively at a time when political Islam is challenging and calling into question our rule of law.

"That PEGIDA protesters have advertised their goals in an exclusively peaceful manner is to be welcomed. Because the rule of law, tolerance and freedom of religion are fundamental Western values, the PEGIDA movement must leave no doubt that it is precisely these values that it seeks to defend."



tem, shows it is now the seventh most used currency for payments. Portfolio investors are seeking it out, particularly after the opening last month of the Shanghai-Hong Kong stock connect, an initiative that provides the most unfettered access yet to the Shanghai stock market for foreigners holding offshore *renminbi*. Western governments are endorsing the currency, with the UK, Australia's state of New South Wales and the Cana-

dian province of British Columbia issuing *renminbi*-denominated debt in the past months. Michael de Jong, finance minister of British Columbia, says the debt issue fulfilled several aims, including improving ties with China and attracting financial services from the US.

"I see the full internationalisation of the *renminbi* as inevitable; it's a question of when," adds Mr de Jong.

Such optimism will be welcomed in Beijing as it pursues a master plan to break free of US dominance in global finance and create a parallel, Sino-centric system that takes its cue from a mighty renminbi. Of course, much could yet conspire to blow China's ambitions off course. But if even half of what it envisages is achieved, the impact on US debt financing, the future of development finance and the opening of Chinese financial markets to international capital would be profound.

junk status," and will get downgraded by the credit agencies in 2015, according to Alexi Kudrin, the country's former finance minister. Kudrin reportedly resigned in 2011 over disagreement with Putin's increased military spending. Now he expects lots of bankruptcies in Russia's private sector over the next year, while banks will be bailed out with billions of *rubles* provided by the government.

External debt is calculated to be some \$500 billion owed

by Russian firms, with a quarter of that payable in 2015. With international credit unavailable, defaults look unavoidable. The Economist doesn't expect a government default, as occurred in 1998, "This time a string of bank failures, corporate defaults and a deep recession look likelier. Even so the pain from these could spread abroad quickly, both to countries that rely on Russian trade (exports to Russia account for fully 5% of GDP in the Baltics and Belarus) and through financial ripple effects. Banks in both Austria and Sweden are exposed."

No one expects oil prices to re-

bound immediately, in fact most observers see the price going lower in the near term. Putin's popularity at home is bound to suffer profoundly as the people begin to pay a heavy price, exacted in part by western sanctions as punishment for military adventures into Ukraine. There is even quiet speculation that he might lose his grip on power as the Russian economy sinks deep into recession. Might he lash out with more military provocation as his subjects suffer the humiliation of desperate circumstances, or find a little humility and back off? Stay tuned.

And they are complaining that they get too much attention from the police, when everybody knows, and it has been widely advertised, that the saggy pants syndrome is a method for concealing weapons and contraband.

They torched businesses all over Ferguson. In New York, protesters blocked the Brooklyn Bridge and numerous well-traveled thoroughfares.
